B. All Exhibits must be professional in appearance. No hand made signs are allowed.

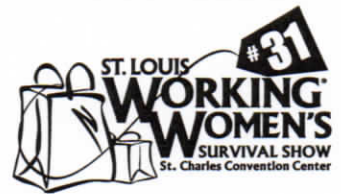
C. Only services listed on this application & pre-approved by show Management will be allowed in Show.
